Other Charges

Hardisty Heavy Surcharge (\$/m ³)	[U] \$1.59	Under this tariff, a surcharge has been applied to the Tariff Rate for Heavy Crude.
Loss Allowance	[U] 0.15%	Under this tariff, a deduction will be made by the Carrier to cover losses inherent in the transportation of Crude Petroleum.
Excess Basic Sediment & Water (BS&W) Surcharge (\$/m ³)	[U] \$2.20	Where Crude Petroleum is received at BS&W levels in excess of limits specified in the Rules and Regulations.
Intra-System Transfers	[U] \$200.00	Under this tariff, a charge is payable by both transferor and transferee in respect of each intra-system transfer.
LMCI Abandonment Surcharge (\$/m ³)	[U] \$0.08	Under this tariff, a deduction will be made by the Carrier to cover the future cost of abandonment as a result of the Land Matters Consultation Initiative (RH-2-2008, MH-001-2013).
Non Performance Charge (\$/m ³)	[U] Posted Tariff	Under this tariff, a penalty may be applied by the Carrier in times of apportionment when volumes received do not meet defined thresholds set forth and in accordance with published Rules & Regulations.
